Session Overview:

We invite **professors**, **researchers and students** in public administration and policy studies to submit proposals for a special **poster session** titled "**Building a Bridge: Connecting Korean and U.S. Public Administration for Renewal and Resilience**" at the 2026 American Society for Public Administration (ASPA) Annual Conference.

Jointly organized by the **Korean Association for Public Administration (KAPA)** and the **ASPA Section on Korean Public Administration (SKPA)**, this session seeks to strengthen dialogue between Korea and the United States—and between practitioners and scholars—by sharing innovative ideas, practices, and research that advance renewal and resilience in governance.

Aligned with **ASPA's 2026 theme—**"Building a Bridge to Renewal and Resilience"—this session aims to strengthen academic dialogue across borders and generations by highlighting evidence-based insights that advance renewal, resilience, and innovation in governance.

Scope and Topics:

We welcome **empirical, theoretical, and comparative research** from faculty, doctoral students, master's students, and researchers in the field of public administration and policy.

While posters related to Korea are preferred, they are not required. Topics are open, and submissions may present ongoing projects and preliminary findings. Topics may include, but are not limited to:

- Governance innovation and administrative reform
- E-government, digital transformation, and data governance
- Crisis management, resilience, and risk communication
- Collaborative governance and intersectoral partnerships
- Citizen engagement, transparency, and trust in government
- Artificial intelligence and emerging technologies in public service
- Ethics, equity, and leadership in government
- Comparative perspectives between Korea and the United States

Proposal Submission Guidelines (SKPA-managed Research Poster Submission):

- Eligibility: Open to faculty members, researchers, and graduate students from Korea or the Korean public administration community in the United States.
- Language: Posters/proposals must be submitted in English
- Submission requirements:
 - Author(s)'s information: Full name(s), affiliation, position, email address
 - o **Title of the poster:** up to 15 words
 - Abstract (up to 150 words): Include 1) a clear research question or topic, 2) theoretical foundation or conceptual background, 3) methodology and data sources (if applicable), 4) expected empirical or conceptual findings; and 5) expected implications or contributions.
- **Poster Format**: Accepted presenters will receive detailed guidelines on poster size, layout, and setup from SKPA prior to the conference.
